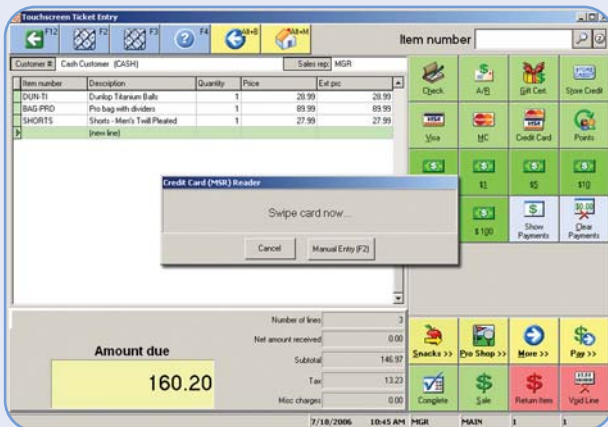

HOW DOES CPGATEWAY WORK?

To authorize a charge, obtain the credit card information by using a magstripe card reader or by entering the card information manually.

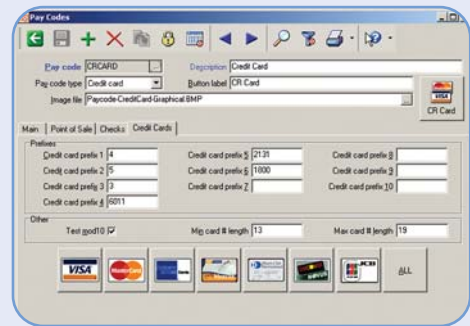
The CounterPoint system requests an authorization from CPGateway. CPGateway obtains the authorization from your processor and quickly passes it back to CounterPoint. Because CounterPoint connects to CPGateway via the Internet, and CPGateway maintains a constant high-speed connection to your processor, you avoid the delays associated with dial-up connections.

CounterPoint and CPGateway are designed to ensure that you will continue authorizing credit cards—no matter what. If your high-speed Internet service fails, CounterPoint automatically switches to dial-up mode. All authorizations, whether from CPGateway or dial-up, are identical and can be settled in the same batch.
